Foote takes USAID to Lower Zambezi for wildlife protection

The US Agency for International Development (USAID) has launched the refurbishment of the Mukamba Gate Complex at the Lower Zambezi National Park to help protect the country's forests and wildlife.

And US Ambassador to Zambia Daniel Foote says if Zambia's forests and wildlife were lost, then the country could lose a critical driver of economic growth for its local communities.

In a statement issued by the US Embassy in Lusaka, activities such as wildlife tourism and beekeeping were only possible through conservation.

"The US government, in partnership with the Zambian government's Department of National Parks and Wildlife, officially launched the refurbished Mukamba Gate Complex at the northern entrance to Lower Zambezi National Park. The complex benefited from support of the U.S.

Agency for International Development's (USAID) Community Forests Program. The launch included event also the graduation of 22 Community Scouts, who in collaboration with the local Community Resource Boards, serve as frontline advocates for forest and wildlife conservation. And US Ambassador to Zambia Mr Daniel Foote notes that 'If we lose Zambia's forests and wildlife, we lose a critical driver of economic growth for our local communities. Activities such as wildlife tourism and beekeeping are only possible through conservation," statement read.

The USAID Community
Forests Program,
implemented by BioCarbon
Partners Ltd is a five-year,
\$14 million programme
aimed at reducing
greenhouse-gas emissions
through the protection of
Zambia's extensive forests.
"To date, the programme

has put over one million



hectares of forest under sustainable management. Zambia's forests play an important role in mitigating climate change by locking up carbon dioxide drawn from the ambient air. That locked

carbon can then be sold as a 'carbon credit' or 'carbon offset' to companies and governments from countries around the world to help offset the carbon dioxide they emit through manufacturing, transportation, and electricity generation. The revenue from the sale of these offsets returns to the communities that protect the forests," read the statement.

"Carbon offsets, therefore,

provide a means for communities to play a role in the global economy by mitigating the effects of climate change while reducing their poverty, and improving their lives.To help protect our forests and wildlife, USAID's Community Forests Program invested in the refurbishment of the Mukamba Gate Complex. As a result, the complex now includes an improved security checkpoint, an office building, and Wildlife Police Officer housing. This important entry point into Lower Zambezi National Park is now betterequipped to support both park management and

Dictators hate critics, but patriotism demands that citizens speak out - Musa

Former Attorney General Musa Mwenye State Counsel says oppressive and dictatorial regimes always despise citizens who criticise them, but says it is the patriotic duty of those who are governed to speak out in defence of their Constitutional rights.

In his festive statement shared on Facebook, Musa who also served as Solicitor General under late Michael Sata's Patriotic Front, urged citizens to show love to their families this Christmas, and encouraged critics to show loyalty and patriotism to the country by speaking out against wrongs in society.

"December is a month in which we ought to focus on love. Love for our families but also love and patriotism for our country. The word 'patriotism' is often misunderstood and sometimes

deliberately misrepresented. Criticism of Governments or ruling parties and comments adverse governments are routinely classified as unpatriotic. By definition, patriotism is a devoted love, support and defense for one's country. Patriotism is therefore loyalty to the country and not loyalty to any one person or group of persons," Mwenye said. He went on to list countries that had oppressive regimes and never tolerated critical voices.

never tolerated critical voices.

"Africa has seen several dictatorial and corrupt regimes. At different times in the history of this continent, patriotism has demanded that those Governments which are corrupt and dictatorial be criticised and condemned by citizens for abusing the countries we love. The Central African Republic had Emperor Bokassa, Zaire

(now the Democratic Republic of Congo) had Mobutu Sese Seko Kuku Ngbendu Wa Za Banga while Uganda had Idi Amin Dada Oumee. Just to the south of our own Beloved Zambia we had Ian Smith in Southern Rhodesia (now Zimbabwe) who declared Independence from his Kith and Kin in England under Unilateral Declaration of Independence (UDI). In South Africa we had the racist Apartheid government," he recalled.

"All the governments cited above were vile, oppressive and dictatorial. In some cases they were also corrupt, incompetent and uncouth. In those countries, it was everyone's patriotic duty to speak out against these regimes and to condemn their senseless acts of oppression and misrule. It was also the highest form of patriotism not

only to condemn the needless corruption of some of these regimes (whose scale could only be correctly described as a primitive accumulation of wealth), but also to take a stand against oppression and corruption."

He stressed that patriotism is never supposed to mean loyalty to an individual.

"Patriotism demands us to be loyal to the country and not to an individual or a political formation. If acts of economic sabotage are committed by those within our groupings or political formations, we must speak in defence of the country. A Merry Christmas and prosperous 2019 to all friends, family and Patriotic Zambians. May Zambia continue to experience peace, tranquility and prosperity in 2019 and beyond," stated Mwenye.

Speaking when he featured on ZNBC's Sunday interview programme, Chitotela said the public would not have been questioning the amount spent on the construction of the toll plaza had EIZ been as proactive as the Economics Association of Zambia (EAZ).

He argued that the EIZ had not come out to breakdown the cost of each of the components that had been installed at the new toll gate.

"A lot of people have said that: 'you can build a toll plaza at US\$500,000' and I have

challenged them, even in Parliament I did challenge them that, if you can, come with the specific Bills of Quantity (BoQ), specific designs like Michael Chilufya Sata, and then you build a toll plaza at US \$500,000. Just mention one country in the region and that toll plaza, I have even told RDA that I am ready to step down that we have betrayed the Zambian people. That US\$500,000 can't even buy software for you to propel a toll plaza like Michael Chilufya Sata.

We did a survey, we checked regionally and internationally; a toll plaza on the dual carriage way in America is costing US\$12 million and that's a fact, you can google. In Zimbabwe, a toll plaza like the one we built in Chongwe at US\$1.7 million in Zimbabwe, they've built it at US\$2 million. So, I wanted to do a cost-comparison analysis. You are talking about the Michael Chilufya Sata, which spans on the dual carriage way," Chitotela explained.

"I want Zambians to challenge me, and that's why I challenged my colleagues in Parliament from UPND that, we built Michael Chilufya Sata at around 38 K39 million, while Manyumbi Toll Plaza, which is a span on one road built by someone, who was a UPND candidate in Nangoma constituency (Nzovu Transport) at a cost of K48 million. It is this government that came to terminate after he could not finish on time. And

Chilufya Sata...Zambians have been demanding for a BoQ! You can go to RDA, and what I did on Thursday in Parliament, I even laid on the table the BoQ so that members of parliament can go through and Zambians can have access and interrogate... I think that's why even His Excellency, the President (Edgar Lungu), has complained against the 'Laissez-faire' attitude by the Engineering Institution of Zambia. They are the professionals, if they could be as proactive as the Economics Association of Zambia is, to come to the Zambian people and explain, then none of these questions could have arisen!" Chitotela also regretted that people could be comparing the cost of the newly-constructed former president Rupiah Banda's retirement house, the lavish Makeni mansion, to a toll plaza, which he insisted was made up of sophisticated equipment.

"I saw comparisons where Zambians were comparing a residence to a toll plaza, which has sophisticated equipment. I want to speak to this that when you check the civil works at that toll plaza, it cost us about US \$1.9 million. Tolling systems and booth equipment cost us about US \$161,700. If you check power supply and related installation, US \$270,537. Signal lighting for the traffic control, its about US \$59,000. Design fee, it cost us US \$95,000. Surveillance system, US \$193,000. The preliminary works and generals, US \$319,000. Value Added Tax... because without VAT, that toll plaza was costing us less than US \$4 million, it was about US \$3.7 million. So, I must explain that if the Engineering Institution of Zambia were as proactive as the Economics Association of Zambia... these are the colleagues whom RDA contracted to do the design. I have been speaking to EIZ in private, but now I need to tell the Zambian people that I have been speaking to them, but they are not being as proactive as we expect them to be," Chitotela complained.

Meanwhile, he disclosed that government had realised toll fees in excess of K797 million from various toll plazas countrywide from January to November this year.

"From the time we started road tolling in Zambia, we've raised in excess of K2.6 billion. From January to November this year, we've raised in excess of K797 million. If you check, today, I think Zambians are able to tell that we are having perfect roads," argued Chitotela.

"If there is one thing PF has been credited for, it's infrastructure development. President Lungu's development agenda on infrastructure is second to none, and that's why even our opponents are not criticizing that President Lungu has not delivered in terms of infrastructure development; the only thing they are going with now is that there is corruption and tribalism so that they can cause paralysis in the operation of government because they know that if we let this team of men and women under the leadership of President Lungu, they will have no message in

Patriotic Front Secretary General Davies Mwila says Zambians will awaken to the political reality that the PF was a "generation of achievers" 100 years after Independence in 2064 as a result of all its achievements.

In the weekly newsletter to News Diggers! where he outlined the PF's achievements since forming government in 2011, Mwila prophesied that by the stroke of midnight on October 24, 2064, Zambia will wake up to a truth that the PF was a "generation of achievers."

Mwila explained that the PF government's visionary

approach to wealth-planning for Zambia through the implementation of the party manifesto, as well as the Seventh National Development Plan (7NDP), is designed to support the attainment of the goals of Vision 2030.

"At the stroke of midnight on 24th October, 2064, Zambia will, indeed, awaken to one undeniable truth and reality: that ours was a generation of achievers, a generation of men and women who, propelled by the energy of patriotism, changed this country forever," Mwila added.

He stated that the PF's visionary approach will lay the foundation for turning Zambia into a developed country by 2064.

government's visionary approach to wealth-planning for Zambia, through the implementation of the PF Manifesto, as well as the 7NDP, is designed to support the attainment of the goals of Vision 2030, which will in-turn, lay the foundation for turning Zambia into a developed country by 2064. The PF, led by President Edgar Chagwa Lungu, is laying the foundation, not just for the next generation, but also for subsequent generations to come by taking significant steps towards the crossgenerational accumulation, conservation, utilisation and transfer of the wealth of Zambians yet to be born,"

Mwila stated. He also highlighted some achievements that the PF government had made in the agriculture and infrastructure sectors, with critical

transactions. "In order to achieve agricultural diversification in terms of crops, fisheries, livestock and forestry products - as espoused in the 7NDP - the PF government under President Edgar Lungu is implementing the following programmes. The Crop, Forestry, Fisheries Livestock Product Diversification Programme: There are numerous strategic interventions currently implemented

the PF government under this Programme, some of which are espoused in the following paragraphs. For example, in April, 2018, the government acquired the ZamPalm Oil Palm Tree Plantation in Kanchibiya District in Muchinga Province, from Zambeef Products Plc at a cash consideration of US \$16 million. ZamPalm Oil Tree Plantation is owned by the Zambian government through the Industrial Development Corporation (IDC). The IDC acquired 90 per cent shares in the operation from Zambeef Products Plc," Mwila narrated. He stated that there was a huge market gap of oil products, which Zambia could leverage from the ZamPalm oil.

"Currently, only Tanzania and the Democratic Republic of Congo (DRC) produce their own palm oil crude - the rest of the countries, including Zambia, import from Malaysia and Indonesia. There is, therefore, a huge market gap, which Zambia can leverage through ZamPalm, especially given the fact that the estate can produce up to 100 tonnes of crude palm oil in a month from its primary processing plant. And once at full capacity, the plant could feed refineries such as the Global Industries in Ndola with a steady flow of raw materials for processing into ready-for-use edible oil all year round," he explained.

Mwila also recalled the US \$55.4 million Cashew Nut Project in Western Province, which he said had already started yielding positive results, among others.

"Furthermore, government under President Edgar Lungu, launched the US \$55.4 million Cashew Nut Project in 2015 in Western Province with the aim of diversifying the economy and creating employment. For instance, by 30th November, 2017, this US \$55.4 million project in Western Province had directly benefited 15,000 farmers in Western Province. At full capacity, the project will benefit a total of 60,000 targeted beneficiaries in the 10 participating districts in Western Province," stated Mwila.

"The PF government has also successfully revived the Kawambwa Tea Estate, which is currently fully operational. At present, the PF government has invested over K30 million into the Estate, and this has led to the creation of 500 direct local jobs. In order to further accelerate economic diversification, as well as create employment in rural areas, the PF government is also seeking prospective investors with the capacity to commercialize the production of salt in Mpika District and other viable projects within the district and other areas countrywide."

Ndola women plead not guilty to abduction, indecent assault

Five Ndola women have pleaded not guilty to a charge of abduction and indecent assault on a female.

Fact before court are that on December 1, 2018, Precious Kapambwe 25, Bridget chisha 21, Magrette Mwansa 25, Catherine Banda 29 and Maureen Mutale 29, while acting together abducted the named victim and caused her actual bodily harm, buy inserting a beer bottle into her private parts.

It is alleged that on the material day, in Ndola's New Mushili township, the victim was having drinks at Start Point Bar at Masala main market with Harrison Mwanza, the husband to Kapambwe.

Whilst at the drinking place, Kapambwe showed up in the company of her other four friends.

It is alleged that upon seeing his wife, Kapambwe's husband run away leaving the victim alone.

Kapambwe then picked the victim by force and took her to home where she was allegedly forced to undress.

And in the video which has since gone viral on social media, the women were seen holding the victim's hands and legs while another was seen placing a bottle of castle beer in the victim's private parts.

When the matter came up for plea Monday afternoon after a new charge of abduction was added, the five pleaded not guilty.

Ndola Principal resident magistrate, Obbester Musukwa adjourned the matter to December 26 for commencement of trial while the five were remanded in custody.

PAC hears how recalled diplomats leave foreign missions in debts

parliamentary Public Accounts Committee (PAC) yesterday learnt how the Ministry of Foreign Affairs has been struggling with lack of funds to repatriate recalled diplomats from various missions abroad.

And the Committee further learnt how missions abroad have been subjected to settling debts and bank loans obtained by recalled diplomats. This came to light when Foreign Affairs Permanent Secretary Ronald Simwinga and Zambia's High Commissioner to Namibia Stella Libongani, Zambia's Ambassador to Zimbabwe Emmanuel Chenda, Zambia's Charge d' Affairs to Geneva Margaret Kayemba, and other Ministry staff appeared before PAC to respond to audit queries cited in the Auditor General's report for the financial year ended December 31,

The audit report had earlier highlighted the Ministry's failure to repatriate recalled diplomats from Ankara, Tokyo, New Delhi, Rome and New York.

Simwinga in response said his

Ministry had requested for funding amounting to K40 million from the Ministry of Finance to transport all the recalled diplomats, but only K10 million was released.

"I wish to submit to the Committee that a request for funding amounting to K40,000,000 to transport all the recalled diplomats was made to the Ministry of Finance, and that an initial funding amounting to K10 million was released for the activity. The Ministry has since disbursed funding to the missions abroad," Simwinga responded.

Simwinga also told the Committee that the estimated cost for each diplomat to be repatriated was about K90,000.

In another query, High Commissioner Libongani's mission in Namibia was cited for outstanding bills not cleared by re-called diplomats totalling K102,700.

"During the year under review, three diplomats were recalled from foreign service namely; Deputy High Commissioner, First Secretary for Political/Administration and Third Secretary-Personal Secretary. During the same period, the High Commissioner resigned from the Foreign Service. An examination of accounting and other records revealed that the diplomats left outstanding bills, unretired imprest and unrecovered salary advances totaling K102,700," cited the Audit Report.

In justifying that, Simwinga stated that the bill recoveries for the deputy High Commissioner were paid through a casualty notification form. The audit report further cited that the former First Secretary for Political/Administration left an unsettled car loan and overdraft facility at Nedbank Namibia amounting to US\$5,094.97.

"The former First Secretary for Political/Administration left an unsettled carloan and overdraft facility at Nedbank Namibia of US\$5,094.97 (N\$71, 239.55) and the officer did not declare the outstanding bills and loan to the Ministry, contrary to minute No.MFA/STA/2804 DATED 23rd March, 2016. In this regard, the Bank lodged in a complaint to the High Commissioner on the failure to repay the loan putting the name of the High Commissioner into disrepute," the

audit report revealed.

Further, the former deputy High Commissioner left an outstanding salary advance and a debt to a travel agency for air tickets bought on credit amounting to K217,367.

And the audit report cited a former Third Secretary-Personal Secretary for an outstanding advance of K107,214 (US \$7,669.13) when she was recalled from the foreign service. For the bill accrued by the third secretary, Simwinga explained that recoveries had already been effected through payroll as the culprit was still serving.

In another query, the High Commission in Windhoek Namibia was also cited for approving payments amounting to K596,126 above the threshold permissible of the head of mission.

"The Public Procurement Act No.12 of 2008 provides that the Head of Mission shall approve procurements up to a maximum of K10,000. Contrary to the provisions of the Act, the High Commissioner approved 22 payments in amounts totalling K596,23 (N\$625, 668.96) for the

procurement of various goods and services, which were above her threshold," cited the audit report.

In response to the above query, Simwinga said the High Commissioner had been cautioned to strictly adhere to the provisions of the law and other regularities.



in Harare was also cited for approving 30 payments totalling K511,728 above his maximum threshold of K10,000. Meanwhile, the Auditor General's report cited the mission in Brussels for its outstanding debt by recalled staff, which amounted to K62,517 and K32,857, which was accrued through medical insurance and damages to the

residence as well as special advance. It was also discovered that another recalled second secretary at the same mission at the time of her return owed a local bank amounts totalling K546,000, while another one owed K26,020,72

But as usual, Simwinga gave a uniform response, saying the recoveries were done through the Casualty Notification Form upon payment of gratuity.

The Forum for Democratic (FODEP) has observed that the ongoing debates, following Constitutional Court's ruling in President Edgar Lungu's eligibility case, have potential to spur instability in Zambia. In an interview, FODEP executive director Chifwembe Mweenge blamed this misunderstanding on the 2016 amended Republican Constitution, which he said was done in a hurry and has

a lot of lacunas.

Mwenge explained that if any civil unrest was to arise due to differences in opinions regarding President Lungu's eligibility, poorer Zambians would suffer the consequences.

"The ConCourt ruling on

left the country talking and divided. There are those who are saying it was the right move and those who are saying it wasn't. But again, one thing for sure is that, we are a nation of laws and we need to respect our own laws. So, it's important for our leaders, both in the opposition and in government to ensure that, as they agitate or put forward their opinions regarding the ConCourt ruling on the eligibility of the President, they should do so within the

the President's eligibility has confines of the law," Mweenge left the country talking and | said.

"We really are believers of freedom of expression and government needs to facilitate for that right. We need to express our opinions in terms of how we feel. We feel that it's not in any one's interest to fuel civil strife because at the end of the day, we know that the people who normally get affected when there are any confusions, it's women and children and the poor. Those who have got money fly out and go to other places. So,

yes, we ascribe to freedom of expression and we feel that the government ought to facilitate for that because we believe that the more people talk, the more they are able to air out their opinions, the better."

He observed that the reason for the ongoing confusion in the country was the 2016 amended Constitution.

"The current Constitution has brought us this confusion! All of us will have to agree that we are where we are because we did ourselves this favour. With that acceptance, we need to ensure that going forward, the Constitution-making process is given ample time. That is why in many cases, these processes are opened up to the people. Much as we agree that the referendum failed, I think that the method of adopting constitutions in Zambia have always left the very beneficiaries of that Constitution at the back," Mweenge said.

"The politicians get the centre stage and when they do that, they are normally protecting their own interests. If they see that perhaps they didn't have enough time to read through and understand some of the things, then they come back and find someone to put the blame on. We have had the issue of the grade 12 certificate, which also did a lot of damage to many politicians who didn't have [the] qualification, some of them even going to an extent of forging certificates. This, to us, demonstrates that first of all, the people who are in front of couching the document and also ratifying it via Parliament, do not take seriously the issue of constitution-making."

He pointed to the need for Zambia to relook the lacunas in the Constitution, warning that leaving the status quo would only mean shelving a problem that would eventually turn the country upside down.

"In moving forward, we need to be very pragmatic. We need to ensure that the entire process is opened up. We feel that nothing basically should be an exclusive right for the legislature in as far as constitutional-making is concerned because this very important document has the capacity to turn this country upside down. You saw this on the issue of the 14 days, and now this issue of President Lungu," said Mweenge.

"All these issues, if you put them together, they are telling us that we need to ensure that constitutional-making process is not exclusive to the politicians. It should not be given alone to the politicians, it must be opened up. Yes, we understand the financial issues, but when we look at times when we started to amend the Constitution, we have been at this process for more than five times. Every time we are making a constitution because we feel there is something wrong. Even as we are talking about lacunas, it's important that this process is not rushed."

Sishuwa has also condemned President Lungu for likening the numerical superiority of the Chinese to cockroaches. In a statement, Monday, Sishuwa urged President Lungu to apologise for his "ill-advised, irresponsible and poorly chosen remarks".

"It is unacceptable to stereotype any of people as thieves or cockroaches-like disappointing when such cruel prideful prejudices come from the President. The President's comments are not excusable. Neither do they need any clarification sugar-coating. are simply crude, gross, and demeaning most irresponsible. disappointed, extremely though not surprised, that the President missed a chance to apologise when he was leaving for Japan since he likes holding press conferences at the airport. I hope he apologises, when he returns from Tokyo. If he had a more competent effective political advisor than Kaiser Zulu, President would have by now proffered a 'humble' apology inspired by 'genuine' remorse and regret," Sishuwa stated.

He urged President Lungu to draw lessons from Levy Mwanawasa on the political consequences of disparaging any ethnic group.

"The deliberate efforts of

I recall that in March 2003, then President Levy Mwanawasa described MMD figures, mainly from Luapula and Northern provinces, who did not support his anti-corruption campaign as 'stinking and dirty'. Last week, President Edgar Lungu stunned the whole country when he made reference to the Chinese people, saying they were many and as resilient as cockroaches, which can survive any tough environment. He said just like stubborn cockroaches that hide anywhere they find space, like in the fridge or stove, Chinese are all over Zambia and it is impossible to stop their influx.

"This cry about Chinese won't help us. Chinese population is about 1.3 billion. So, invariably, you will find Chinese all over and when you say, 'eliminate Chinese from Zambia, you are wasting your time. You say 'let's Chinese from chase Zambia', how? Because in Europe they are there, in America they are there, in Australia they are there. Allow them to conduct business so that we work together and prosper our country. Let's not be xenophobic, it will not help us," that's what President Lungu said initially.

But in his humble Presidential wisdom, he did not think that he had succeeded to deliver his point, so he went on to unleash the most unthinkable analogy in describing the Chinese people.

"Someone told me that Chinese are like cockroaches. The Chinese, like cockroaches, resilient and able to survive in extreme temperatures. Cockroaches are resilient, they survive in fridges, they survive in stoves, they survive extreme temperatures, very cold rooms, you'll find a cockroach, very hot you'll temperatures, will find a cockroach. everywhere. We can't eliminate them, let's just work with them."

Someone has to remind President Lungu that what comes out of his mouth effectively becomes government position, and consequently turns into policy. It seems this man forgets that he is Head of State, he thinks he still has the liberty to crack 'tavern jokes' like he used to do back in the days in Chawama compound.

Mr Lungu, Sir, this is not a casino. You are a President and presiding over the affairs of 16 million citizens, some of whom don't even know you and don't care whatever alcoholic addictions you may have. But it is your duty to represent them diligently and diplomatically to the outside world.

It is hard enough to imagine that someone had the audacity of going to President Lungu, a sitting Head of State, to make such a degrading and inhuman reference to the Chinese people. But it is even worse to learn that, instead of taking offence and reprimanding whoever coined that stupid analogy, our President felt this was such an accurate definition of Chinese people that deserved to be repeated from a Presidential podium at an economics forum.

To be very honest, we actually don't believe that anyone told this to President Lungu, he thought about this reference himself and used it because that is what he thinks about the Chinese people. In our view, President Lungu doesn't naturally like the Chinese, but he simply loves their money. If these Chinese did not have as many dollars to stash into his private pockets, our President

would have worse references to describe citizens of the Asian country who are in Zambia to do business.

We saw that when parliamentarians challenged Vice-President Inonge Wina to explain this statement, the old lady struggled to defend this stereotype remark from her boss, and all she could say was "you cannot call human beings cockroaches." Now, imagine if it was a member of the opposition who had made such a reference to the Chinese people. That person would have been in police cells today for uttering words culpable of inciting xenophobic attacks on foreigners. But police have closed their ears because President Lungu was simply doing 'chimbuya' with the Chinese, we are told.

We have to make it clear that our position has not changed, we don't like what

the Chinese are doing to Zambia. It is our opinion that a majority of Chinese who are in the country to do business have exacerbated corruption in government. Using their financial influence, they have taken over control of institutions that are responsible for running tender processes and awarding contracts; and on the other hand, they have taken over small businesses from Zambians. Some of them have no regard for the labour laws of this land and they treat local workers as they please, knowing very well that no one can touch them as long as influential Cabinet ministers are on their pay roll.

It is disheartening to hear a President fail to address such critical issues and simply saying: 'tolerate these Chinese like you have tolerated the cockroaches in your houses, because


they behave the same way.' Chinese are not cockroaches, Mr Lungu, they are human beings with ears; they are capable of listening when someone stamps authority and tells them to stop what they are doing wrong. That is how they have curbed corruption in China, because they know that their government means business, when it says 'stop

But our President is on corruption. weak His entire Cabinet is corruptible. That is what strengthens the relationship that this government has with the Chinese people. It is all about their money. It doesn't matter whether Chinese behave cockroaches; to them, as long as they take money to State House, they will let them exploit the country's resources (like cockroaches) under the cover of night while Zambians are asleep.

It is the same thing that can be said about President Lungu's relationship with Bemba-speaking people. Our President was able to speak with confidence that out of every 10 Bembas six are thieves, because that is what he thinks about the people from the North. Just like he doesn't need the Chinese for anything else, President Lungu doesn't need anything from the Bembas, apart from their votes. He thinks they are thieves, but he is tolerating them because they are the majority tribe and he needs them to stay in power.

For a man who has no clear or traceable origins in Zambia, this was not only a miscalculated stereotype statement, but also a political gaffe that may backfire on him.

Saudi Arabia on Monday slammed as "interference" US Senate resolutions over its war in Yemen and critic Jamal Khashoggi's murder, warning that the move could have repercussions on its strategic ties with Washington.

The Republican-controlled Senate voted on Thursday to end American military support for a Riyadhled war in Yemen, and separately held Crown Prince Mohammed bin Salman responsible for Khashoggi's killing.

The largely symbolic vote dealt a fresh warning to President Donald Trump, who has staunchly backed the Saudi regime in the face of intense global that analysts outrage say has left the kingdom diplomatically weakened. "The kingdom condemns the latest position of

allegations and rejects the blatant interference in its internal affairs," the foreign ministry said in a statement released by the official Saudi Press Agency. On the Yemen measure, which more broadly attacks the president's prerogative to launch military action, 49 Democrats or their allies voted in favour, along with seven Republicans, while another three Republicans abstained.

The Senate also approved a resolution condemning Khashoggi's murder and calling Crown Prince Mohammed bin Salman, Saudi Arabia's de facto ruler, "responsible" for it. Saudi ministry warned that the kingdom would not tolerate any "disrespect" of its rulers. "This position by the US Senate sends the wrong



messages to all those who want to cause a rift in Saudi-US relationship," the ministry said.

significant negative impact on this important strategic relationship."

- 'Vulnerable to pressure' -

A day after the Senate vote, Secretary of State Mike Pompeo again defended US ties with Saudi Arabia on national security grounds, saying the kingdom was a bulwark against common foe Iran.

The Senate resolution acknowledged the US-Saudi ties were "important" but called on Riyadh to "moderate its increasingly erratic foreign policy".

Protesting Ethiopian soldiers given jail terms

A military court in Ethiopia has sentenced 66 soldiers to between five and 14 years in prison for marching on the residence of Prime Minister Abiy Ahmed in October.

The government said the soldiers were asking for a pay rise but Mr Abiy later insisted they had wanted to kill him.

"These sentences delivered today will serve as lessons," prosecutor Cap Hailemariam Mamo told reporters.

The defendants' lawyer said he would lodge appeals for a few suspects.


One defendant sentenced to 14 years in prison, while 65 others were given jail terms ranging from five to 13 years, for "violation of military ethics", Col Meshesha Areda, head of the military tribunals directorate, said quoted by Reuters news agency.

The 66 were among 200 soldiers in fatigues and red berets who marched to the prime minister's office in the capital, Addis Ababa. At the time, Mr Abiy defused the situation by

ordering them to do pressups and joining in but he later told parliament that he was very unhappy with the situation.

"The march of some members of the army to

the National Palace [the prime minister's office] was not only unlawful but very dangerous, because the intention was to abort the ongoing reforms," Mr Abiy told MPs during a questionand-answer session. "Meanwhile, after the situation was brought under control, some forces were heard saying: 'He escaped before we could kill him," he added. BBC

UN calls for 'credible' probe into Khashoggi's murder

UN chief Antonio Guterres called Sunday for a "credible" probe into journalist Jamal Khashoggi's murder in Saudi Arabia's consulate in Istanbul. "It is absolutely essential to have a credible investigation and to have the punishment of those that were guilty," Guterres said at a conference in Doha.

The UN chief said he had no information on the case except what had been reported in the media.

Khashoggi, Saudi contributor to the Washington

Post, was killed on October 2 shortly after entering the kingdom's consulate in what Riyadh called a "rogue" operation.

Saudi Arabia has repeatedly rejected Turkish demands to extradite suspects connected to the murder of the journalist, a critic of Crown Prince Mohammed bin Salman.

Turkey's foreign minister said on Sunday that Saudi Arabia has not yet shared information on a "local collaborator" in his country.

Mevlut Cavusoglu said at the

conference that Riyadh has neither dislosed the name nor the facial composite of a suspect in Turkey.

"Why don't you share it with Turkey?" he asked.

"We know that (Khashoggi's) body was cut in pieces and his body was taken out of the consulate building, but we don't know where the body is. "This is the main question, we need to find out."

On Saturday, Cavusoglu said that his country would "not give up" on establishing the truth about the murder.

Earlier this month, the minister said Turkey was in talks over a possible United Nations investigation into the killing which has provoked global outrage.

According to Turkey, a 15-member Saudi team was sent to Istanbul to kill Khashoggi, a palace insider turned critic of the regime.

Riyadh has since detained 21 people over the murder.

Despite speculation that the powerful crown prince ordered the hit, the kingdom has strongly denied he was involved.

The murder has damaged Rivadh's international reputation, and Western countries including the United States, France and Canada have placed sanctions on nearly 20 Saudi nationals.

"No doubt Cristiano is the man of the Champions League, he has always shown that, with goals and victories. Our team is very strong and we can be calm and confident."


