Some media houses have become political scavengers - Mwila

By Zondiwe Mbewe Patriotic Front Secretary General Davies Mwila has charged that some media houses have become political scavengers and abandoned their role of informing, educating entertaining. and And Mwila says within the seven years the Patriotic Front has been in power, the media industry and broadcasting subsector has grown rapidly. Meanwhile, Mwila says although PF believes in press freedom, it's also of the view that media freedom comes with responsibility. In PF's weekly news letter to News Diggers! Mwila stated that as the country moved closer to attaining the Vision 2030 of becoming "prosperous middleа income country by 2030", a diverse media industry was crucial to disseminating information and providing checks and balances. He bragged that within the seven years that the PF had been in power, the media industry and broadcasting

subsector had grown more rapidly with 111 radio and 42 television stations. "There are a number of key developments the country is presently enjoying under the PF government, that seemed farfetched under the previous regime seven years ago. For instance when the Patriotic Front formed government, in 2011, there were only 40 Radio Stations; and a modest number of less than five Television stations operating in our nation. However, within the seven years PF has been in office, the media industry and broadcasting subsector has grown exponentially," he stated. "The government has opened up and expanded the airwaves to hitherto unimaginable levels; there are currently 111 radio and 42 television stations currently licensed in Zambia." that the Mwila stated growth unprecedented of the media industry in Zambia was a direct result of

the implementation of the Patriotic Front manifesto. He added that the splendour of PF's achievements outshines the envy, fake news and yellow journalism of their critics. "PF government under President Edgar Chagwa Lungu is committed to sustaining the gains made in the media industry during the last seven years under our watch; we are resolved to continue fostering an environment for a diverse and pluralistic media fraternity to thrive in. Like a starry night sky, the splendour of our achievements outshines the darkness of the maice, envy, fake news and yellow journalism of our detractors. No one can dare take away from our track record in opening up the airwaves," Mwila stated. He however stated that although PF believed in various freedoms, the party was of the belief that media freedom came with responsibility. Mwila added that the broadcasting industry in Zambia was governed by the Independent Broadcasting Authority (IBA) Act. hence any breach was against the laws of Zambia. "Every licence has its limits. Whilst we are avid believers in various freedoms including freedom of the press, we believe as all right thinking believe, that every freedom has its responsibilities. responsibility," he stated. "The freedom that comes Broadcasting with а Licence does not walk separating alone; а broadcast licence from the responsibilities and obligations that go with it as promulgated in the IBA Act would be as irresponsible as removing a suckling child from its mother's breast and placing it in the bosom of a wild animal." Meanwhile, Mwila charged that some media houses become political had scavengers and they had abandoned their role of informing, educating and entertaining.

"Sadly, some media houses have taken this route and they have become political scavengers; abandoning their role of informing, educating and entertaining; they have instead resorted to breaching the terms of their licences; feasting on twisted political agendas and foraging opinionated news thereby misinforming, mis-educating and misentertaining the nation with their inflammatory and irresponsible overhyped reporting designed to arouse violent sentiments amongst citizens," stated Mwila.

NHA director of finance denies failing to follow procurement procedures



And when the matter came up for plea before magistrate Felix Kaoma, Monday, Chewe pleaded not guilty. The matter has since been adjourned to April 10 for commencement of trial. The accused's police bond has also been extended.

On Friday last week during the 'Let the People Talk' program on Radio Phoenix, Kasolo said it annoyed him that foreign dignitaries such as those from the U.S Embassy were undermining the sovereignty of the country by commenting on the suspension of Prime TV, ignoring the violation of media freedom by their President Donald Trump.

In a statement, Monday, Msoni observed that Kasolo's language was inviting the American government to consider imposing sanctions on those he described trouble makers in as the PF government. "Kasolo is being cheeky and mischievous in his approach towards the legitimate concerns expressed by our bilateral partners on the flimsy closure of Prime TV for 30days. We think that sovereignty is not an insulation or convenient cover for undemocratic practices. The World is now one global village and any village bullies must be tickled at all levels to ensure that the rule of law is upheld," Msoni said. "It is lawlessness to shut down a business on flimsy political grounds without

taking the plight workers into consideration. Effectively, this is a ruse meant to frustrate and ground the television station. It is a precursor prelude and towards complete shutdown of the Television station." Msoni said the United States of America government would be in order to consider imposing sanctions Zambia. Muzalema Mwanza, the founder of Safe Motherhood Alliance, a Zambia-based social enterprise that develops simple, low-cost disposable baby delivery kits has won the Pitch@Palace Africa 2019 prize.

According to a statement issued by Zambia's first secretary for press in the UK, Abigail Chaponda, the announcement was made at Pitch@Palace Africa hosted by Prince Andrew, the Duke of York at St James's Palace London on 7th March 2019. Zambia's High Commissioner to the United Kingdom Muyeba Chikonde and members of Staff from the Mission were in attendance to support Muzalema.

The Kits developed by Safe Motherhood Alliance contains tools for midwives in Zambia delivering babies in clinics or at home births. Each kit includes basic items like a scalpel, sanitary pads, a hygienic sheet and cotton swabs, requirements needed for would be mothers. 17 entrepreneurs coming from six different African countries presented their innovations.

"It is an honour to win the Pitch@palace Africa 2019. My innovation was inspired by my own experience when giving birth to my first child. At the hospital I was told that I needed to provide my own baby delivery kit. I decided to come up with Safe Motherhood Alliance and we produce thousands of kits each month, and we sell them to pregnant women who can't afford baby delivery kits," said Mwanza.

And High Commissioner Chikonde said Mwanza had made Zambia proud. "I am encouraged to see such wonderful talent from African

engineers whose innovations have solutions to change their communities," said High Commissioner Chikonde. The Zambian engineer will receive eight months of bespoke business mentoring, training, and networking opportunities, to enable her turn her prototypes into a profitable business that will have economic and social impact.

Lusaka Province Minister Bowman Lusambo says the ruling party has no political competitor for 2021, boasting that other contenders will only participate because Zambia is a democratic state.

In an interview, Tuesday, Lusambo said Zambians had already decided to re-elect President Edgar Lungu because he had done a lot since he became Head of State.

"2021 the people of Zambia have decided already, 2021 is a time for his Excellency Edgar Chagwa Lungu, President, Commander in Chief of the Armed Forces, he will be re-elected back into government because he is doing a lot of things since he assumed the office of presidency. And I can assure you that we don't have a competitor for 2021. Other people will participate, we are in a democratic dispensation, we allow people to participate in an election but we don't have a competitor," Lusambo boasted. And Lusambo, who is also deputy campaign manager for the Roan Parliamentary by election slated for April 11, said former area member of parliament Chishimba Kambwili failed to develop the constituency despite being given key government positions. "If he has failed, he has failed. Because the President and the system have been giving all of us CDF and given Cabinet portfolio as minister, he has been minister of sport, he has been minister of labour, he has been minister of foreign affairs and he has been minister of information. And if he has failed, then he is just a failure because with all those portfolios, and you fail to work for your people in a constituency like Roan, you will be considering yourself as a failure and there is nothing that you can tell the people of Roan," Lusambo said.

"Because the President and the government recognised you in the first place and they gave you a

portfolio to respect the people of Roan. But we have seen actually that he failed as an individual, that is why we want to go and control the mistakes he made when he was on our party ticket, because PF is not a failure, PF is a party for success. That's why we'll be going there with the word of hope and we are certain that come April 11, we are carrying the day." He said the PF was confident of retaining the Roan Parliamentary seat. "Roan Constituency is a PF seat, it has been a PF seat under the former MP, Chishimba Kambwili and we are going there as defenders. We know what is happening on the ground because we are in government, we know each and every challenge which our people are facing

Women shun politics because it's aggressive - Gender Minister

By Zondiwe Mbewe Minister of Gender Elizabeth Phiri has urged women in developing nations to actively engage in political governance in order to bridge the social and economic gender gap, for sustainable development. And Phiri has observed that educated women in Zambia are shunning politics because the male-dominated political sphere has remained aggressive. According to a statement issued by First Secretary for Press at the Permanent Mission to the United Nations in New York, Wallen Simwaka, Tuesday, Phiri was speaking when she opened the 63rd UN Commission on the Status of Women (CSW) side event held under the theme "Promoting Rights-based Social Protection Policies for Gender Equality, a prerequisite for Social Justice and Sustainable Development." The side event was organized by Friedrich Ebert Stiftung (FES) in conjunction with Zambia, Women in Informal

People's Alliance for Change (PAC) president Andyford Banda says it would not be shocking if all the Bishops presiding over national dialogue resigned like Bishop Sydney Sichilima due to lack of sincerity among politicians. In an interview, Banda said the Bishops were trying hard not dent their names through their involvement in the dialogue process. "The first thing that came to my mind when I saw that Bishop Sichilima had resigned is I sympathized with him because I think the Bishops tried their level best to help this country but the

She noted that competition in elective political positions in many countries was often too aggressive for the full participation of educated women, hence creating gender inequalities. Phiri, however, said government had continued to create an enabling environment for the promotion of gender equality and empowerment of women through a range of innovative policies meant to close the gender social, economic and political disparities. "In Zambia, like many other countries, particularly in developing nations, for women to get to high elective political positions, they have to defeat men and it is not an easy undertaking. Educated women are shunning politics because the male-dominated political sphere has remained aggressive. But women have to actively engage in the political governance of countries if the social and economic gender gap has to be closed for sustainable development," she said. And Phiri said Zambia remained committed enhancing gender to mainstreaming through the development of policies programmes and that would be able to reduce poverty and vulnerability among women and girls. said Zambia's She implementation of the Social Cash Transfer Scheme had so far improved nutrition levels among vulnerable rural households and they could now access adequate food. Phiri further said government was implementing the Food Security Programme which was aimed at enhancing food security at household level

through crop diversification, conservation farming, as well as the promotion of alternative livelihoods among communities. "The role of the Social Protection System is not only reducing poverty but also for achieving human development outcomes such as nutrition, health and education and tackling social inequality. Social protection programmes have the ability to tackle social constraints such as lack of income or incomegenerating capacity," said Phiri. The 63rd Commission on the Status of Women was also attended by Ministry of Gender Permanent Secretary Dr Auxillia Ponga, Zambia's Representative Permanent to the United Nations Ambassador Lazarous Kapambwe, a civil rights activist from Kenya Helen Mudora and Dr Laura Alfers of Women in Informal Employment Globalising and Organising in South Africa.

Lack of sincerity among politicians will push church out dialogue - Andyford

politicians are not working to achieve their targets. It is true that to preserve the integrity of the church, the Bishop did well to resign and I wouldn't be surprised that all the Bishops that were ready to work with the political parties in the national dialogue followed suit because what we have realized is that there is lack of sincerity in politicians and the Bishops are really

trying hard not to have their names dented by their involvement in the dialogue process. So the first safest thing to do in as much as they have an obligation to help the country go through this dialogue, the safest thing is for them not to get involved and that is why you saw the resignation of Bishop Sichilima," Banda said. Banda said it was

important for politicians to be sincere and further warned that it would be difficult to find a mediator for the national dialogue if the church pulled out. He said as long as the politicians were not sincere in their dealings, the church would keep excusing itself from the process. "So we hope that politicians can be a bit sincere because outside the church, I think

it would be difficult to find a mediator to mediate the national dialogue. I think what we see is that everyone is gunning to see how electoral reforms can advantage or disadvantage the opponent and I think that should be the goal of the dialogue process. I think the goal of the dialogue process is to actually ensure that proper laws are implemented [and] that would last a test of time as opposed to laws that will target political competitors in this process. So we need to make sure that people are sincere to enact laws that will fever every political party [such that] if PF today was in the opposition, they shouldn't cry foul and say 'no, we want the dialogue process to change this. So we want laws that are going to last a test of time. So as long as politicians are not going to be sincere, we shall see the church excusing themselves from the national dialogue," he said. Meanwhile, Banda said the PF had failed the youth. "The challenge we have with this government is that they have taken us back to many years. So it's very difficult for us to score them and say 'this is what

they have done.' When they came in 2011 they came with projects which in essence they were supposed to have empowered the youths but those projects have disappeared and there is no money to run the projects and then we are in debt, meaning that more and more youths are unemployed. So there was no plan by the PF government to ensure that the Eurobond they borrowed would sustain the youths for a long time to come up with plans on how best they can create jobs," said Banda. "So they need to come up with empowerment projects that will not target PF cadres or people that are affiliated to the ruling party but they need to come up with empowerment programmes that would target people who are competent, people who can actually work for this country. And youths must actually look for opportunities in their communities. And also I would like to advise the youths to get involved in productive politics because they should not just be used as tools of violence. There is more that they can do in politics."

Airtel sues Kapiri man for refusing to pay back K200,000 erroneously sent to him

Airtel Networks Zambia has sued a Kapiri Mposhi resident in the Lusaka High Court for refusing to pay back K200,000 which was erroneously paid to him by the company The company wants James Kumwenda to pay it back the K200,000 plus interest. In a statement of claim filed in the Lusaka High Court recently, Airtel Networks Zambia stated that it was at all material times, a public limited company whose main business was in telecommunications. Airtel Networks added that Kumwenda was at all material times a resident of Kapiri Mposhi and owner of Subdivision K of farm number 3790. It explained that Kumwenda sued the company in 2017 and it was

agreed and ordered that he was to be paid K95,000 as full and final settlement of the said action. Airtel Networks claimed that in settling the said judgement sum, the company, through its Finance Department, erroneously overpaid Kumwenda by K200,000. "By an action in the High Court, the defendant (Kumwenda) sued the plaintiff (Airtel) under cause number 2017/HB/30 and the said matter was settled by consent order whereby it was agreed and ordered that Kumwenda was to be paid K95,000 as full and final settlement of the said action," read the statement of claim. "In settling the said judgment sum, Airtel Networks Zambia through its Finance Department, erroneously

overpaid Kumwenda by the sum of K200,000. Instead of K95,000, Kumwenda was paid K295,000." The company claimed that Kumwenda was not legally entitled to the said overpayment of K200,000, adding that the defendant had refused to repay the said money to the company. stated that Kumwenda It acknowledged admitted and receipt of the K295,000 and had no defence to the company's claim. The company lamented that it had suffered loss and damage as a result. The telecommunications company is now claiming the sum of K200,000 which Kumwenda received from it, interest, costs and and any other relief the court may deem fit in the circumstances.

So on the part of the President and the youths of his political party is that he wants them to lead by example, and the test for them is that in parts where the Patriotic Front commands huge support, he wants to lead by example and show that it's possible to conduct very

competitive politics and at the same time, peaceful. So he wants no violence whatsoever in the elections in Bahati, in the elections in Roan, elections in Kafue and any other areas where we have local government elections," "Minister of Home Affairs Honourable Kampyongo is under very strict instructions to ensure that as chairperson for youth and national security in the party, the PF youths are peaceful and exemplary. And by extension, the youths participating in elections must be peaceful. Any deviant behaviour is

not a matter of negotiation. responsibility The honourable Kampyongo has is not to negotiate with trouble makers, is not to seek compromise, is to ensure that every part of the Zambian soil is peaceful," Chanda said. And Chanda said President Lungu was expecting other political party leaders to instruct their youths to avoid violence. creation of job opportunities in Zambia is imperative to match the growing number of youth entering the labour force every year. With over half of the global population under the age of 30, the demographics are similar in Zambia, nothing has been done to address this minefield. Many have paid cheap lip service to youth empowerment but the policies in place belie all the rhetoric which is why employment opportunities for our youth have remained pitifully low. Scrapping student meal allowances and the increase of Medical students' Clinical placement fees by 400% is not just shocking but an aberration. Especially that the very politicians who endorsed these moves were themselves recipients of a free education," Hichilema stated. How much government money was allocated for this purpose in the last budget?" Hichilema asked. Hichilema stated that there was need for government policies to be pivoted on youth empowerment. "Being surrounded by 8 neighbors, Zambia has a market of 250 million people on its doorstep. What should be promoted is a

engagement. The future of Zambia depends on tapping into this infinite pool of talent. Let us be the generation that turned the tide and tackled youth unemployment face on," stated Hichilema. Meanwhile, in another statement, Kalaba observed that the youth of today had significant entrepreneurial skills but the environment was not enabling them to participate in the private sector. "Today I see a youth full of innovation, but his innovation is not harnessed. Today I see a youth with significant entrepreneurial skills, but the environment is not enabling him or her to be a private sector participant. Today I see a youth scientist and technologist returning home from abroad, but the government has no plans to enhance the diminishing science base and industry for technology transfer. Today I see a differently gifted youth yearning for skills, but the government has no plans for such youth. On this youth day, I appreciate the fact that in 2019, we have a youth population that is far more educated than ever before. Today, we have a youth population far greater in numbers with collective zeal and energy which, when well harnessed, can place Zambia on a global development path vielding economic dividends," stated Kalaba stated. "This government has simply failed to find the golden key to unlock Zambia's socio-economic potential and job creation for the youth. Zambia has created a desolate and desperate youth. A few desperate youth are being exploited by politicians as tools of political violence and insults for political expediency, especially by the ruling party. These youths have been used to define politics as a dirty and dangerous field, hence perpetuating fear in those who have a positive agenda for genuine change engendering youth development."

UNZA, CBU impasse signals a broke govt, HH warned them - Mweetwa

UPND deputy spokesperson Cornelius Mweetwa says what is happening at the university of Zambia and Copperbelt University is symptomatic of a broke, clueless government that is governing by chance without a recovery plan. And Chief government spokesperson Dora Siliya says government is deeply concerned with the position taken by University of Zambia and Copperbelt University lecturers who have resolved to down tools until their February 2019 salaries are paid.

In a brief note, commenting on the impasse, Siliya who doubles as Minister or Information and Broadcasting Services said tension is not good for education and hoped that Higher Education Minister Prof Nkandu Luo would bring the issue to a logical conclusion.

"Clearly, government is deeply concerned with the situation at the two public institutions. Tension is not good for the learning environment. It is our hope that soon, the minister in charge will bring this matter to a logical conclusion," said Siliya.

But Mweetwa, who is also Choma Central member of parliament, reminded government that UPND leader Hakainde Hichilema warned of this crisis when the PF was "struggling to control its appetite for borrowing".

"What is happening at UNZA and CBU is symptomatic of the state of governance and the state of the economy. You must be aware that it is not only UNZA and CBU that have gone unpaid, except that these two institutions have felt that they can't take any more than

they have already gone through. They have suffered, if you go at the University of Zambia now, it's a sorry sight. But there are others. People who are in employment at institutions such as Zampost, National Housing Authority and others are not being paid," Mweetwa observed.

"This government is so broke that it is failing to pay public workers at the same time. Some civil servants have just been paid their February salaries after mounting pressure on government. These guys have no money now, but we told the PF a few years ago that the way they are managing the economy, they will soon have a liquidity crunch in the nation, there will be no money. When we told them that, they said 'HH is just being bitter'. Can they now still be able to say HH was bitter with what he was telling them or he was telling them the truth?"

He said winning elections by dubious means was no guarantee that the party would manage the economy.

"There are no two ways of governing a country, you don't govern a country by emotion or by accident. You govern a county by bringing about economic development through well planned policies that are in sync with the capacities of those why are charged with the responsibility of governance. It's not just about stealing votes and saying we have won the elections now we are going to govern because we have a mandate. A mandate should have with itself a skill-set commensurate with the demands and requirements for national governance and economic management. That is what is

absent in the PF, that is why you are seeing universities now reaching those levels," Mweetwa said.

"Right now the Republic of Zambia is struggling to meet its debt obligations, and those governing the country have no recovery plan. Instead they continue to borrow. What about the few years to come when some of the biggest loans they got begin to yield, what will happen? So Zambians need to brace themselves for harder times to come. But what HH has been saying, what we have been telling them, when they could not control their appetite for borrowing, is now becoming true. We want to hear the PF speak up now and say that what is happening at UNZA

and CBU is because HH is bitter." He urged Zambians to reflect on the mandate they gave the PF.

"As UPND, we want to call on the citizens of this country to reflect ... this is the time to reflect on the mandate we give to politicians, that it is not just about handing out power anyhow, it is about giving power knowing that it is that power through the ballot you are giving out that you now have to rely on for your salary increment; you now have to rely on for your terminal benefits; you now have to rely on in order to get a job once you leave college or university. It is that power in the ballot that you are going to rely on whether to remain on the street as a street vendor or not, it is the power in

the ballot that has created the situation we are in today. When we as citizens decide that it is this power we only use it and it is this voice in the ballot that we only speak once in five years. We must be very careful not to trade that voice with Chitenge or T-shirt or little money here and there or even with beer. We should know that that voice is very crucial. If you misplace it to the wrong authority, you are in for it for the next five years before you are given another opportunity to speak again," said Mweetwa.

"It doesn't make sense that the PF is busy chasing its members of parliament to create unnecessary by-elections, yet when it comes to these political events, there is no

day when we have been told that 'this by-election will not take place because government has failed to raise the necessary money for it. Does it make sense? It doesn't. Look at the money that is going into Roan. It will be more money that the money which the workers at UNZA are demanding, it could be more money than what workers at ZAMPOST are demanding. So it's like politics in Zambia is the most important thing at the expense of development, at the expense of the people who voted for us. This is where we are getting to now. People who have to suffer are the people who voted for us while those who are in those comfortable positions continue to live in luxury."

Kambwili being unfairly treated by Speaker, courts, ECZ - CSO

A legal entity civil society organization, AGE Justice International, says the Speaker of the National Assembly, the courts and the Electoral Commission of Zambia have treated Chishimba Kambwili very unfairly.

In a statement, Tuesday, AGE Justice International executive director Philimon Phiri stated that the Speaker and ECZ were in a hurry to declare the Roan seat vacant. Phiri also said it was also unprecedented that the courts had refused to grant

Kambwili judicial review. "It should be noted that the speaker of the National Assembly proceeded to declare the Roan seat vacant following a point of order from the PF:- 1. The Speaker does not have such powers to declare a seat vacant as provided under section 72 of the constitution of Zambia. 2. Declaration of any seat vacant is a preserve of the constitutional court. 3. The roan member was never and not given chance to be heard through the relevant standing committees.

There is a requirement for a speaker to notify the Electoral Commission of Zambia of any seat failing vacant within 7 days, however on the 5th day the ECZ issued a notice for the by-election in Roan. The speaker and the ECZ were in unprecedented hurry to declare the Roan seat vacant. The Roan lawmaker proceeded to court for a Judicial review for the illegal actions of the speaker of parliament and ECZ," Phiri stated.

"The High Court has refused to grant the relief sought.

This is the first refusal by the courts to grant judicial review process to operate as a stay of execution in the history of this country to a serving member of parliament. In all instances were a serving member of parliament has applied for a judicial review to act as a stay of execution, the courts have in all incidents from 1964 to date given the relief sort. Therefore Dr Chishimba Kambwili is for all intent and purpose being extremely unfairly treated by the speaker, ECZ and the courts. It amounts to denying of justice to a citizen of the republic."

He stated that PF were doing everything possible to exclude Kambwili from Parliament.

"It is therefore extremely difficult to exclude the PF from such maneuvers as they hold a world record in interfering with all institutions of governance. We are also fully aware that the PF are spending sleepless nights just to ensure that Dr Chishimba Kambwili does not get a fair hearing and totally exclude him out of parliament as they fear that he will expose all the corrupt leaders in the PF and government. childhood that it's normal for boys to be naughty. This is why women who are beaten in relationships don't waste time reporting the abuse for fear of further victimization. There is even a song that says "Chipuba chandi ndekeni nemwine, chilansunga bwino." (so long he provides, he is my beloved idiot).

Our society today teaches young women that "ubucende wamwaume tautoba ing'anda" (a man's promiscuity doesn't destroy a marriage). And for real, when a woman reports to elders that her husband is having an extra marital affair, they tell her to shipikisha because she will never find a perfect husband who has no bad habits. They say, "you can't complain about a cheating husband because there

are wives out there whose husbands are having children outside wedlock".

This is the reality of the society that we live in. That is the depth of the gender imbalance that we have tolled for generations. Therefore, breaking this shipikisha mentality will take a little more than reading speeches on International Women's Day. It might mean having to first break the very fabric of our society and initiating a cultural remodeling campaign that should be extended to the rural populations where the gender gap is even wider and the traditional norms are even more bizarre.

But while we agree with President Lungu that time is now for our women to demand their equal rights. We would like to draw his attention to yet another thought provoking idea from economist Chibamba regarding Kanyama, how else women can score big in the national development agenda.

Chibamba says women are capable of using their domestic influence at household level to curb corruption, by demanding to know the source of money and properties which their husbands possess.

CHIBAMBA Kanyama: "When corruption eats up a society, it means women have abandoned their calling; they are partakers of corruption, failing to ask their husbands, 'Where did this money come from? My wife once told me, 'you are exposed to opportunities to make money illegally but I will not be a conduit to an

evil that will eat up our own family, giving false hope of eternal security and prosperity'. A smart woman has power to tell the husband, 'unless you show me the source of this money; of this property; of this vehicle, I remain aggrieved because our children should grow up in an environment of sustainable prosperity'. My wife is the guiding light for me, the number one trusted advisor..."

Mr Kanyama is absolutely right. If you look back in recent history, you find that all high profile theft and corruption cases of former government leaders have not excluded their wives. Recently, we carried a picture of a former commander who is jointly charged with his wife in a criminal case. This is


not necessarily because wives are involved in any alleged criminality, but simply because they allowed their names to be used in wrong Instead dealings. of interrogating the source of money, some spouses get excited when their partner is bringing home unexplained wealth. They believe in "kufwa na no!".

In our view, this messages should be directed at President Lungu's wife and his Cabinet Minister's spouses, because these are the people who have access to the little resources that our country is remaining with. Has our First Lady cared to know how her husband has become so filthy rich within a short period? She has to, otherwise it will be quite painful to first of all, shipikisha in her marriage, then later on have to answer for crimes she was not involved in.

A First Lady must be a number one trusted advisor, making sure the President doesn't drag the whole family into a mess after leaving office. Other advisors have their own lives after the presidency, but a wife can't run away from the husband's trouble.

This is also food for thought for those minister's wives who think their spouses are very hard working because they leave the house in the middle of the night for unexplained meetings, where they even get involved in car accidents. If they don't want to interrogate these night covert meetings which are generating wealth, they should be ready to face news cameras at court when the bells come tolling.





Celebrating people living with rare skin condition

Gemma Whyatt has birthmarks covering her upper back, neck, chest and ear, with hundreds of smaller marks all over her body.

It's a rare skin condition called congenital melanocytic naevus (CMN).

24-year-old The from Cambridgeshire is one of 30 people with CMN taking part in an international exhibition.

"For someone else to see the way I look as art and something to be celebrated is really amazing for me," she tells Radio 1 Newsbeat.

Gemma, a fourth-year medical student in Leeds, was born with CMN, which is untreatable: "I was told they were my brown patches or birthmarks."

As a child she says her life was like anyone else's.

'My lucky day', how one man missed flight

A Greek man says he missed the Ethiopian Airlines plane that crashed in Addis Ababa after arriving two minutes late at the boarding gate.

"I was mad because nobody helped me to reach the gate on time," said Antonis Mavropoulos as he recalled his "lucky day".

A second man also says he narrowly missed the flight.

The Boeing plane to Nairobi crashed six minutes after taking off on Sunday, killing all 157 people on board.

The victims are from more than 30 countries, including 32 Kenyans, 18 Canadians, and seven Britons. Antonis Mavropoulos: 'My lucky day'

Mr Mavropoulos, president of the non-profit International Solid Waste Association, said he was initially angry as staff had not helped him and he missed the flight.

"I had a 30 minute connection and my flight arrived on time. My connection ambassador came after I left the plane," he said of the company employee that was supposed to take him to his next flight.

"He was trying to find me. I would like to say many thanks to this ambassador who saved my life. My luggage was on me and they didn't need to wait for me. I saw the last passengers in the corridor," he told the BBC.

Earlier, in a Facebook post entitled "My lucky day," Mr Mavropoulos said he was put onto the next flight to Nairobi and only found out about the crash when he was

stopped from boarding his next flight. He was taken to a police station for

questioning when an officer told him that he was the only passenger booked on the flight that did not board. With a picture of his boarding

pass, Mr Mavropoulos wrote: "The officer told me not to protest but to prav to God."

Police cross checked his identity and questioned him on his reason for not boarding the aircraft. "The wi-fi in the airport was cut and I was worried that the news

might be on the Greek internet and TV. I texted friends as I didn't want my family to be devastated," he said.

"My friend told me the plane had crashed. I decided to call my family to let them know from me." Mr Mavropoulos was reportedly travelling to Nairobi to attend a session of the UN Environment

Programme. He said that many of his friends travelling to the conference were on the flight.

"I had friends who were travelling and were lost. Everyone at the conference is devastated. It's a very sad moment for all of us. It can happen to anyone. It was randomness."

At least 19 victims were affiliated with the United Nations.

He said: "I'm grateful to live and that I have so many friends that made me feel their love?

Ahmed Khalid: Delayed flight Dubai resident Ahmed Khalid said he had missed the connecting flight due to a delay in the first leg of his trip. He was then put on a later flight to Nairobi.

"Everyone was asking the cabin crew what was happening, but no one was saying anything," he told The National newspaper.

"They were just going up and down until one of the passengers saw on his mobile that the first plane which had just flew, like six minutes after it flew, it just crashed."

His father, who was waiting for him in Nairobi, heard the news and immediately thought his son was on the flight.

He said: "I was shocked but shortly after, my son contacted me and told me he is still in Addis and did not board that flight."BBC

"I did normal things and had normal friends and I even did gymnastics and trampolining - which involved a leotard that revealed my birthmarks and I didn't think anything of it when I was growing up.

"It wasn't until I became a teenager that it really affected me.

"I realised I looked different and I felt quite self-conscious about it - I didn't really know anyone else with the condition.

"I used to wear scarves, long sleeves, and I would wear full aussie cozzies instead of bikinis."

But Gemma tells us she just got "fed up" of feeling self-conscious and when she was around 17 she booked a holiday to Spain with her friend where, for the first time in years, she wore a bikini.

"No-one even stared or said anything. It was kind of like exposure therapy in a way.

"I started enjoying life more to the full. It made me realise it's not that big a deal and I didn't need to limit myself."

Gemma was the first person to sit for the photographer behind the How Do You C Me Now? exhibition and tells us it was "scary and nerveracking".

"I was only wearing my pants, with someone I've never met. I wasn't wearing any make-up and I didn't do anything with my hair.

"Usually I like to be in control of how I look and how I'm perceived, especially when taking pictures. But to give all of that to someone else did make me feel quite vulnerable.

"In doing so, it made me come to terms more with how I look and that I can't always have control over how other people see me."

Photographer Brock Elbank says: "It's about celebrating unique individuals and to have hair and make up detracts away from their natural beauty."

CMN charity Caring Matters Now worked with Brock to find those who were willing to take part.

It took three years to complete and features children and adults from 13 countries.

Gemma says people from around the world have already contacted he**r.BBC**

He had pledged last week that he would step down early if re-elected - but the guarantee failed to placate the thousands of demonstrators. Algeria had been hit by strikes by teachers and students, as well as shops closing and train services being suspended as thousands took to the streets. What changed on Monday? Pressure mounted on Mr

Mohamed Salah says he will "sacrifice" his Champions League dream if it means giving Liverpool supporters what they crave.

The Anfield club are chasing glory on two fronts, with star striker Salah, 26, admitting Europe's elite competition is his priority over the Premier League.

With Liverpool heading into Wednesday's last-16 second leg clash with Bayern Munich with the tie poised at 0-0 and the club second in the Premier League a point behind leaders Manchester City, success in both competitions is a possibility.

While Salah acknowledges the Champions League is the most "prestigious competition", he knows Liverpool fans want a first title of the Premier League era more than anything. "I will be honest with you, the

most prestigious competition for me is the Champions League," Salah told Sky Sports

"But the dream for the entire city and the club is the league. "So, I am happy to sacrifice my dream for their dream but if we win both that would great and this is what we are trying to do."

Despite some questions over his recent form , the Egyptian disclosed that he is ready to help Liverpool make the most of any City slip in the title race. Salah is Liverpool's top scorer with 20 goals but has not found the back of the net in his last five matches in all competitions, stretching back to a 3-0 win over Bournemouth at Anfield at the start of February.

"The competition is very tough and we have difficult games left as do they," he added. *Goal*

City launch child sex abuse compensation scheme

Manchester City have launched a compensation scheme for survivors of historical child sex abuse in football, the Premier League club have announced.

The scale of abuse among youth teams in Britain came to light in 2016, when a string of ex-footballers, including England internationals, told of the crimes inflicted upon them, including years of being repeatedly raped.

Former football coach Barry Bennell was last year sentenced to 30 years in prison for abusing youth players, with the judge branding him "sheer evil".

City said they commissioned a review in November 2016 into whether the club was used by Bennell and "any other individual to facilitate alleged sexual abuse of children from 1964 to the present day".

That review, which is ongoing, led to the "uncovering of serious allegations of child sex abuse in respect of another individual, John Broome."

Bennell, who was a youth team coach with City and Crewe, was convicted of dozens of offences committed against 12 boys he coached between 1979 and 1991.

Broome, who is now dead, was involved in City's youth setup in the 1960s.

City said the compensation scheme applies to the victims of Bennell and Broome.

"The club's review remains ongoing and Manchester City FC continues to be restricted as to what it can make public at present for legal reasons," the club said in its statement. *AFP*

Real Madrid president Florentino Perez hopes "both" Kylian Mbappe and Neymar could join his club in the future, while also hoping Zinedine Zidane might lure the France star to the Spanish capital. The Frenchman was named as head coach on Monday on a contract through the

2022 season, returning to the club he departed 10 months ago, having won his third straight Champions League title.

Zidane will be tasked with righting the ship after his successors Julen Lopetegui and Santiago Solari struggled to live up to expectations following the Frenchman's departure last summer.

And Perez, speaking to reporters after presenting

Zidane to the media, admitted he hopes that the presence of the France legend at the helm once more might tempt the 20-year-old star to Madrid. "Zidane's French so maybe he could do something with Mbappe," Perez, with a laugh, told reporters.

When pressed over whether he believed Mbappe could be convinced to join Madrid, the club president deflected, instead saying their focus was on finishing the season.

"Right now, all we are concerned with is ending the season well and start preparing for next season," Perez said.

Neymar has also been rumoured as a Madrid target, with reports suggesting the club would shatter the transfer record PSG paid for the Brazilian while offering to make him the highest-paid footballer in the world. It has also been reported that such a move would take Madrid out of the race, at least in the short term, for Mbappe, given the cost of landing both stars. However, when asked who he would choose between the two PSG stars, Perez instead answered "Both." Neymar has been coy on his future as well, a few weeks ago saying he was happy in Paris but admitting Madrid was an attractive option and that he was uncertain over what the future may hold.
